### Payment of Above Fees

All tuition fees for international students must be paid in full for the period of registration prior to the student's first day of classes. Tuition fees are subject to change.

### Terms and Conditions

A non-refundable deposit of \$1,500 must be submitted with the original application to cover the costs of registration and administration.

Trenton Christian School will review the Student Tuition Fees & Payment Contract of the International Family on an annual basis.

Students will be placed at the grade levels assigned by the school. To be exempt from Language Assistance (ESL) the student (s) must be tested and found to be at least at their own grade level, according to Canadian standards for reading and writing.

Trenton Christian School is **NOT** responsible for any medical costs, insurance costs, or any other related costs however incurred.

Tuition Rates are subject to a minimum annual increase of at least 3% (as set at the spring Membership Meeting)

This agreement may be terminated with 10 days written notice.
